#### **EMV Fallback Protection**

If your debit card chip can't be read and you are forced to swipe the mag stripe, you must input your PIN for approval. This is a safeguard to combat counterfeit debit cards. If you do not use your PIN your transaction will be denied.

### **Mobile App Scheduled Go Live Date is October 1st!**

Our mobile app is on target to go live on October 1, 2022. You will find our app on the Apple and Google app stores. Our app will allow you to more quickly log-in and do your banking on the go. You will be able to access statements, tax documents, transfer funds, freeze your debit card and deposit your checks with remote mobile deposit. Save your gas and stamp money!!
